Preparing for College



MAKING AN APPLICATION

If you are unsure which course you'd like to study, you may be able to attend a taster session for the subject(s) you are interested in.

If you know which course you'd like to apply for, you can apply directly on our website. Click on the course you are interested in studying and click 'Apply Now'.

Once you've been accepted for a course, you will need to come and enrol at the college before you start, so make sure you keep an eye on your emails for your invitation.

Support Starting college

IF YOU'RE AGED 16-18

16-18 Enhanced Bursary

As a student with care experience, you may be eligible for additional financial support which can be calculated as part of a needs assessment. This means you will need to apply for a bursary through your college.

You will need evidence of your care status such as a section 20 letter or supporting letter from your local authority dated within the last three months (this is a letter from your social worker or borough confirming that you are in their care or were in their care at some point in your childhood).

You do not need a bank account to make the application

Borrowing a college laptop

If you don't have access to a computer at home, you may be entitled to the use of a college laptop for the entire academic year.

Supporting your progression

As part of your Care Plan as a student with care experience, the college is required to complete a **PEP (Personal Education Plan)** meeting every term with you, your guardian, Social Worker, college Designated Teacher and your Virtual School Teacher, to discuss your progress, wishes, feelings and aspirations.



IF YOU'RE AGED 19+

Advanced Learner Loan

This could include a contribution to childcare costs, free lunch on full college days, reimbursement for college books, trips and educational visits. You will need to apply for your bursary through the government website, but you can contact the college bursary team with any queries. DID YOU KNOW?

- If you are a Care Leaver in full-time education, **you may be exempt from paying council tax.**
- If you are a Care Leaver and live independently, you may be entitled to up to **70% off your water bill** through discounted tariffs.
- If you are a Care Leaver, aged 25 or under and you are in full-time education, you should not be expected to attend the Job Centre Plus for appointments in person to claim **Universal Credit**, especially during college hours. Your education takes priority, and you should not be expected to look for work during this time.
- You can access free additional tuition for English and maths in college with Get Further by emailing **hello@getfurther.org.uk** If you are struggling with a different academic subject, please contact your Participation Coordinator at the Care Leaver Covenant or personal adviser within your local authority.
- You can access **free counselling through the college** if you're struggling emotionally or with your mental health. Please speak to a member of your support team to be referred.

Financial and Independent Living Support

FINANCIAL SUPPORT FROM CHARITIES

- **Spark Foundation** awards grants of £600 towards expenses including driving lessons, activities and holidays, or setting up home.

- **Capstone Care Leavers Trust** awards grants to people aged 17-25 for further education courses, higher education courses, training courses, laptops, study materials, driving lessons, and household goods (such as sofas, chairs, cookers, fridge, freezer, washing machine etc.)

INDEPENDENT LIVING SUPPORT

- The House Project is a national organisation started by Care Leavers. It provides an opportunity for young people leaving care to work collaboratively and become a team, support each other and learn the skills you need to be independent. Progression and Employment

Progression support and advice (including employment):

- **BECOME** offers advice and guidance for care-experienced young people up to age 27, if you have any questions about your rights and entitlements (be it financial support, housing, education, life coaching etc) or if you just need someone to talk to about how you're feeling. - **EY Foundation** supports young people from low-income backgrounds to get paid work experience, employability skills training and career guidance. <https://eyfoundation.com/uk/en/home.html>
- **SmartWorks** provides one-hour, one-to-one interview preparation and confidence building sessions **for women seeking employment**, and a bespoke dressing consultation with two trained volunteers, to find an interview outfit that will fill you with confidence. Preparing for University

If you are 25 or under and do not currently have a Personal Advisor assigned to you from your Local Authority, please contact your Local Authority and request one if you plan on attending University. They'll be able to help you understand and access all the grants and support you are eligible for in the months leading up to your degree.

When applying for degrees, you can compare university offers of support for those with care experience through <https://propel.org.uk/UK>. Make sure you look at the offers of support for those with care experience pre-application, during your application and after enrolment at the University. Do they have a specified point of contact for support through application? Do they give a contextual offer for those with care experience (where the entry grade requirement for the course is lower than standard)? What is the value of their annual bursary payment for those with care experience? Do they have mentoring programmes?

Many universities offer a 'Supported Entry Scheme', which offers benefits such as contextual offers, a specified point of contact for support through application, mentoring programs and university visits.

For help with your application contact your Careers Advisor within the college or your Participation Coordinator at the Care Leaver Covenant. Make sure you use all your UCAS choices on your application.

Be careful applying to different degrees at the same university through UCAS if it's a competitive course, as it may look like you're unsure of what you want to do. For example, midwifery tends to be a very competitive course so in this instance it's advisable to not put down another subject, such as adult nursing. Admissions tutors will want to see your commitment to that course. If you're unsure, ask your college Careers Advisor for guidance or contact the university you're applying to.

Visit the university campus and get a bespoke tour.

Unite Foundation Scholarship offers free accommodation to successful candidates. They also cover your bills for up to three years of study. www.thisisusatuni.org/unite-foundation-scholarship

The Sanctuary Scholarship is for anyone who has been offered a place at university and is seeking asylum or has refugee status in the United Kingdom. To be eligible to apply for the Sanctuary Scholarship, you must hold one of the following immigration statuses: UK asylum seeker, UK discretionary leave to remain (as a result of an asylum application), UK limited leave to remain (as a result of an asylum application), or Humanitarian protection (as a result of an asylum application). You will also be eligible if you are a dependent of someone with one of these immigration statuses. Research online to find out which UK universities offer Sanctuary Scholarships.
